## **POLISI KUALITI, KESIHATAN, KESELAMATAN DAN ALAM SEKITAR**

Kuantan Port Consortium Sdn. Bhd. komited di dalam sistem pengurusan Kualiti, Kesihatan, Keselamatan dan Alam Sekitar (QHSE) untuk memenuhi konteks organisasi bagi menetapkan objektif, memenuhi keperluan pematuhan terhadap perundangan dan keperluan lain, penambahbaikan berterusan dalam setiap aspek organisasi serta aktiviti perniagaannya.

Dasar ini diwujudkan melalui perundingan dan penyertaan pekerja untuk mencapai program QHSE yang merangkumi perkara-perkara berikut:

Setiap individu perlu menunjukkan kepimpinan yang bertanggungjawab terhadap pencegahan insiden dan kemalangan, dan terlibat secara aktif apabila terdapat risiko kepada pekerja, kontraktor, orang awam, peralatan, persekitaran atau kerja-kerja yang diperhatikan atau dikenal pasti. Sekiranya terdapat sebarang keraguan memberhentikan kerja, perkara tersebut perlu dirujuk kepada penyelia atasan.
